

PIP made £32.3m new commitments during the month across two primaries (£4.7m) and eight co-investments (£27.6m). This included:

- A £4.7m co-investment alongside Altas Partners in HUB International, a North American insurance brokerage company
- A £3.2m co-investment alongside Altamont Capital Partners in Juice Plus, a US direct seller of whole food-based nutritional products






